Introduction

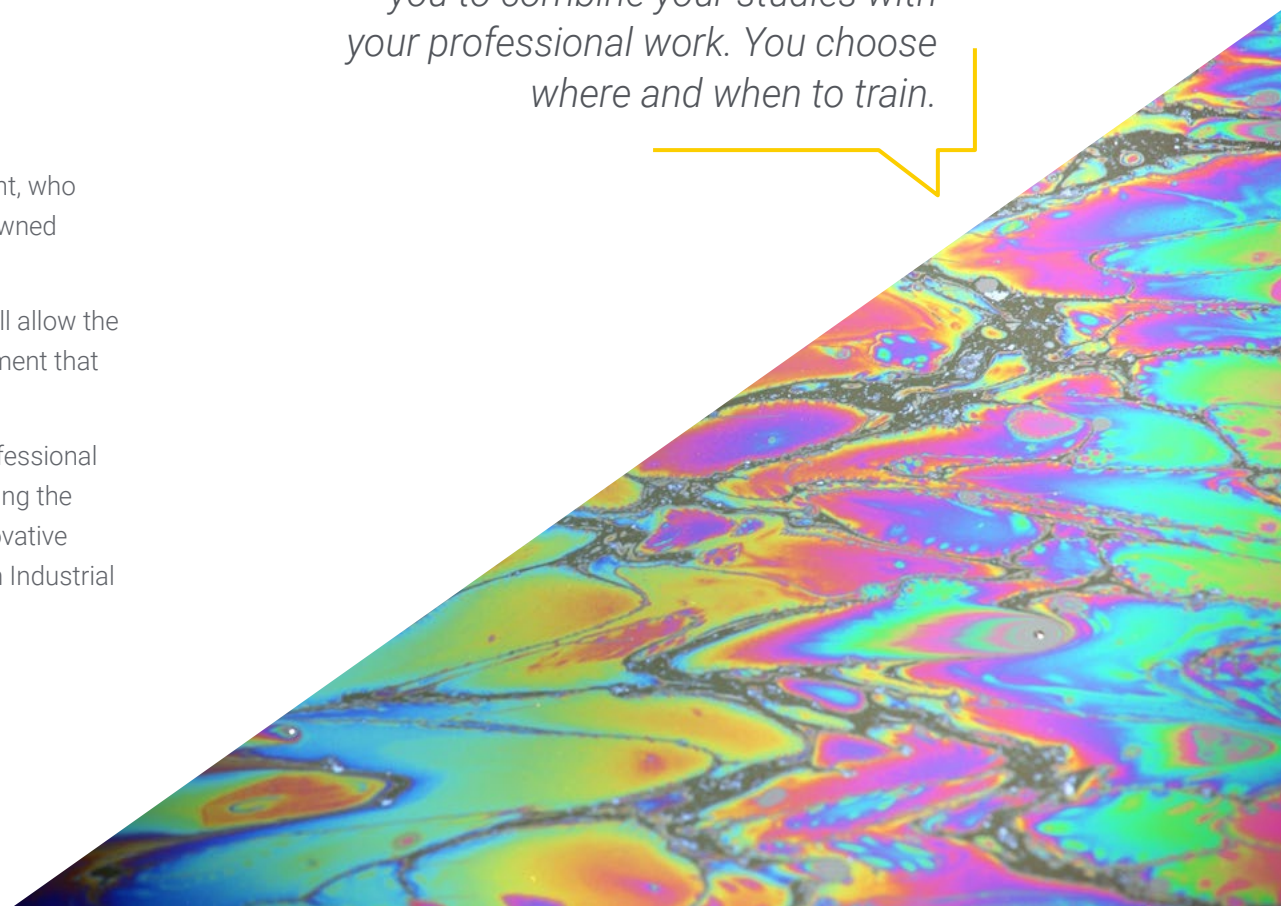

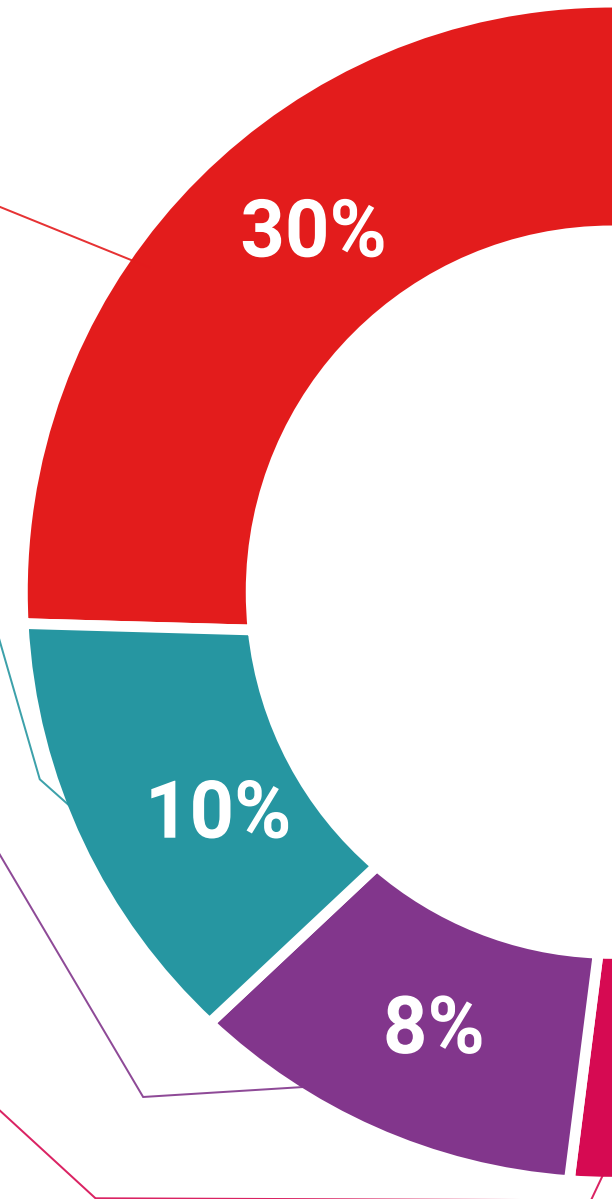
