

In this sense, his clinical specialty is based on the **Invasive Management of Arrhythmias** in patients suffering from **Adult Congenital Heart Disease**.

He has developed his professional work in health institutions of international reference, including the **Johns Hopkins Hospital** in Maryland or the **Beth Israel Deaconess Medical Center** in Massachusetts. In this way, he has contributed to optimizing the quality of life of numerous individuals suffering from diseases ranging from **Atrial Fibrillation** or **Ventricular Tachycardia** to **Structural Malformations of the heart**. This innovation made it possible to address cardiac rhythm disturbances that could not be treated conventionally without damaging nearby critical structures.

On the other hand, he balances this work with his role as a **Clinical Researcher** in Cardiac Electrophysiology. In fact, he has published numerous **scientific articles** in high-impact specialized journals. His clinical findings have contributed to the advancement of the knowledge of health professionals in areas such as **Atrial Fibrillation**, **Resynchronization** therapies or personalized **Cardiac Prototypes**.
