# Introduction

The endocrine system consists of a group of glands and organs that regulate and control various bodily functions through the production and secretion of hormones. Knowledge of the genetic alterations responsible for each disorder that occurs in this process will allow us to understand its molecular pathophysiology and to make more precise diagnoses and more effective therapies.




