# Introduction

Patients with severe burns, who arrive at hospitals in a critical condition, may suffer complications affecting virtually all organs, creating difficulties for the patient's survival. In these cases, correct and early diagnosis can make the difference between life and death. The main objective of this Postgraduate Certificate is to learn about the situation of the critically ill burn patient, in whom complications may occur with dysfunctions in practically all organs. To this end, the frequency and consequences of respiratory, hematological, renal, hepatic, immunological and adrenal dysfunctions will be explained, as well as the possibility of all of these ending in multi-organ failure.

In addition, we include topics that cover complications that, although not exclusive to these patients, are particularly frequent in them. Specifically, these are the following pathologies: intra-abdominal hypertension and compartment syndrome. As for compartment syndrome in extremities, it has been known for a long time, however, until a few years ago no special attention had been paid to abdominal and other compartment syndromes. Therefore, we want to increase the specialization of physicians in this field.

# Methodology

The effectiveness of the method is justified by four fundamental achievements:

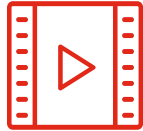

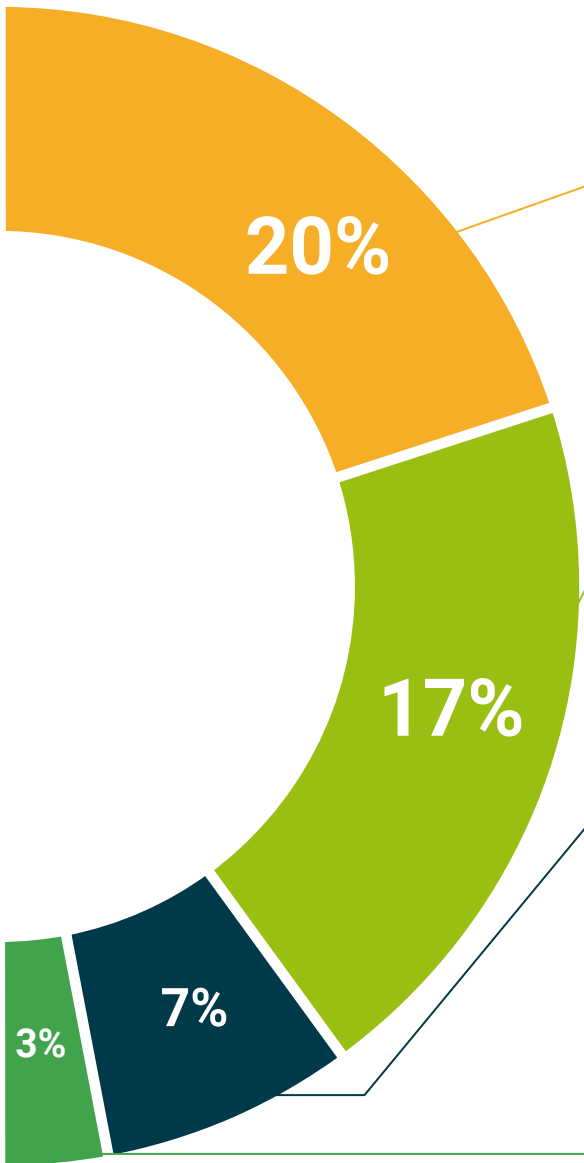
