Introduction

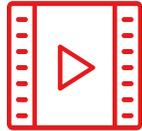

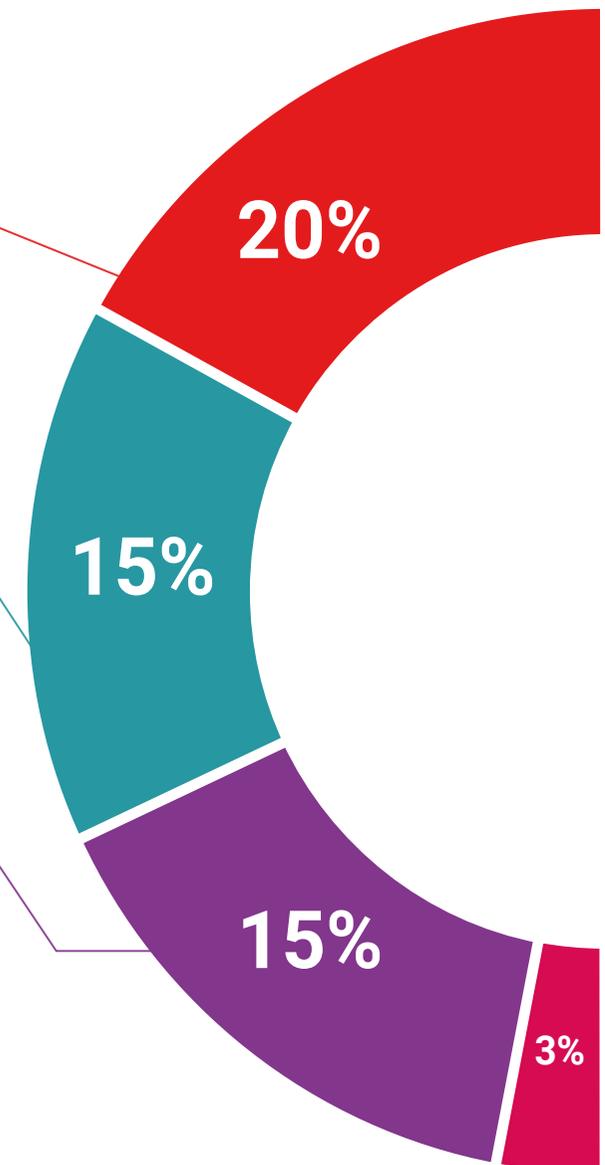

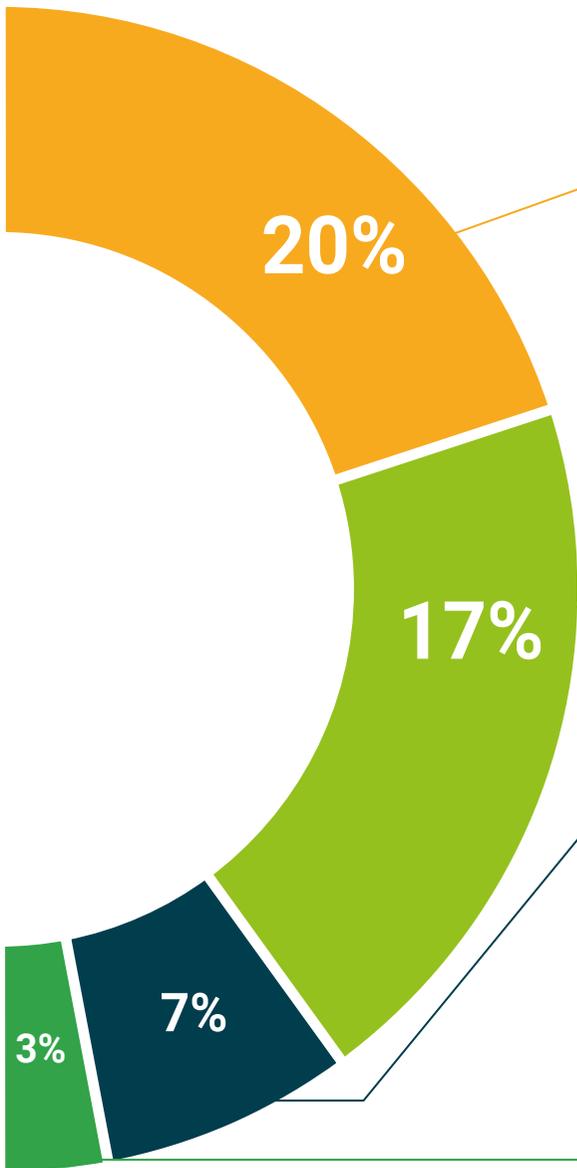
