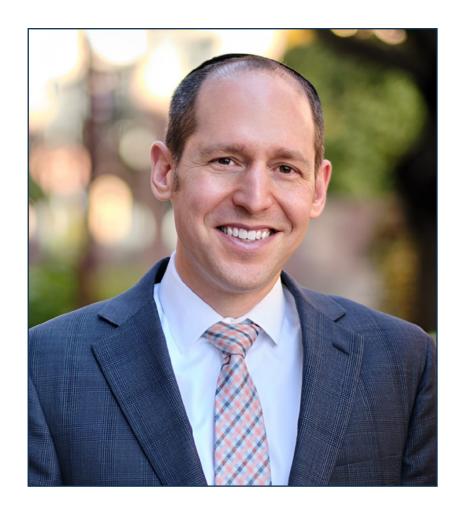
International Guest Director





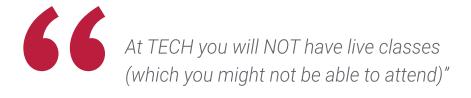
