tech 06 | Introduction

General pediatricians cannot encompass the complexity of all pediatric subspecialties. As they progress in their development, each one of them acquires a specific body and entity to become its own specialty. In addition, the particularities of child development and its variability according to age and other factors do not allow neurologists for adults to cope with the existing demand. All this, together with the great diversity and complexity of neurological disorders in childhood, means that more and more neuropediatric units are needed and the demand for highly trained professionals in this area is increasing.

The weight of neuropediatrics within general pediatrics almost exceeds 25% of the overall demand in specialized care units in our country. This figure, together with the significant increase in overall pediatric demand and despite the current birth rate, suggests a significant increase in the coming years. More and more authors are reporting an increase in the diagnosis of various neurological pathologies typical of childhood, such as disorders within the autism spectrum, learning disabilities, and even neoplasms affecting the central nervous system. This is leading to the development of units structured on the basis of care processes oriented towards specific pathologies and therefore to a need for extremely high need specialization.
