


Module	Practical Activity
Therapy with medicinal plants	Provide recommendations on the appropriate use of medicinal plants and phytotherapeutic preparations, considering aspects such as the clinical history or health conditions of patients
	Inform users about the benefits, risks and limitations of the use of Phytotherapy in order to promote an effective use of herbal products
	Prepare infusions, decoctions or extracts from medicinal plants
	Monitor the response of individuals to the use of Phytotherapy
Natural Medicine for Neurological Disorders	Reviewing the medical history of individuals and their pharmacological treatments to avoid adverse interactions between medications and phytotherapeutic preparations
	Recommend the use of herbal medicines such as valerian, passionflower or lemon balm, for nervous system disorders
	Develop care plans that combine conventional therapies with phytotherapy for the management of conditions such as anxiety, insomnia or stress
	Ensure that patients correctly administer the recommended phytotherapeutic preparations, respecting the dosage and frequency indicated to avoid unwanted effects
Musculoskeletal Phytotherapy	Provide advice on the use of medicinal plants such as turmeric, ginger or arnica for locomotor system disorders
	Teach patients how to safely prepare herbal infusions, ointments, tinctures or poultices with medicinal plants
	Supervise the use of creams or essential oils for topical application, containing plant extracts such as rosemary, arnica or calendula to relieve muscle aches and pains
	Offer people relaxation techniques and stretching exercises to reduce muscle tension, complementing the use of phytotherapy
Skin care with Phytotherapy	Provide recommendations on the use of medicinal plants such as aloe vera, chamomile or lavender for skin care
	Prepare the elaboration of creams, gels or lotions of medicinal plants for the treatment of skin conditions
	Continuous monitoring of the users' skin condition to evaluate the effectiveness of Phytotherapy
	Use medicinal plants with antimicrobial and anti-inflammatory properties to prevent infections in wounds, burns and ulcers


05 Where Can I Do the Internship Program?


06 **General Conditions**

Civil Liability Insurance

This institution's main concern is to guarantee the safety of the students and other collaborating agents involved in the internship process at the company. Among the measures dedicated to achieve this is the response to any incident that may occur during the entire teaching-learning process.

To this end, this entity commits to purchasing a civil liability insurance policy to cover any eventuality that may arise during the course of the internship at the center.

This liability policy for interns will have broad coverage and will be taken out prior to the start of the Internship Program period. That way professionals will not have to worry in case of having to face an unexpected situation and will be covered until the end of the internship program at the center.



General Conditions of the Internship Program

The general terms and conditions of the internship agreement for the program are as follows:

- 1. TUTOR: During the Internship Program, students will be assigned two tutors who will accompany them throughout the process, answering any doubts and questions that may arise. On the one hand, there will be a professional tutor belonging to the internship center who will have the purpose of guiding and supporting the student at all times. On the other hand, they will also be assigned an academic tutor, whose mission will be to coordinate and help the students during the whole process, solving doubts and facilitating everything they may need. In this way, the student will be accompanied and will be able to discuss any doubts that may arise, both clinical and academic.
- 2. **DURATION:** The internship program will have a duration of three continuous weeks, in 8-hour days, 5 days a week. The days of attendance and the schedule will be the responsibility of the center and the professional will be informed well in advance so that they can make the appropriate arrangements.
- **3. ABSENCE:** If the student does not show up on the start date of the Internship Program, they will lose the right to it, without the possibility of reimbursement or change of dates. Absence for more than two days from the internship, without justification or a medical reason, will result in the professional's withdrawal from the internship, therefore, automatic termination of the internship. Any problems that may arise during the course of the internship must be urgently reported to the academic tutor.

- **4. CERTIFICATION**: Professionals who pass the Internship Program will receive a certificate accrediting their stay at the center.
- **5. EMPLOYMENT RELATIONSHIP:** The Internship Program shall not constitute an employment relationship of any kind.
- **6. PRIOR EDUCATION:** Some centers may require a certificate of prior education for the Internship Program. In these cases, it will be necessary to submit it to the TECH internship department so that the assignment of the chosen center can be confirmed.
- 7. DOES NOT INCLUDE: The Internship Program will not include any element not described in the present conditions. Therefore, it does not include accommodation, transportation to the city where the internship takes place, visas or any other items not listed

However, students may consult with their academic tutor for any questions or recommendations in this regard. The academic tutor will provide the student with all the necessary information to facilitate the procedures in any case.
