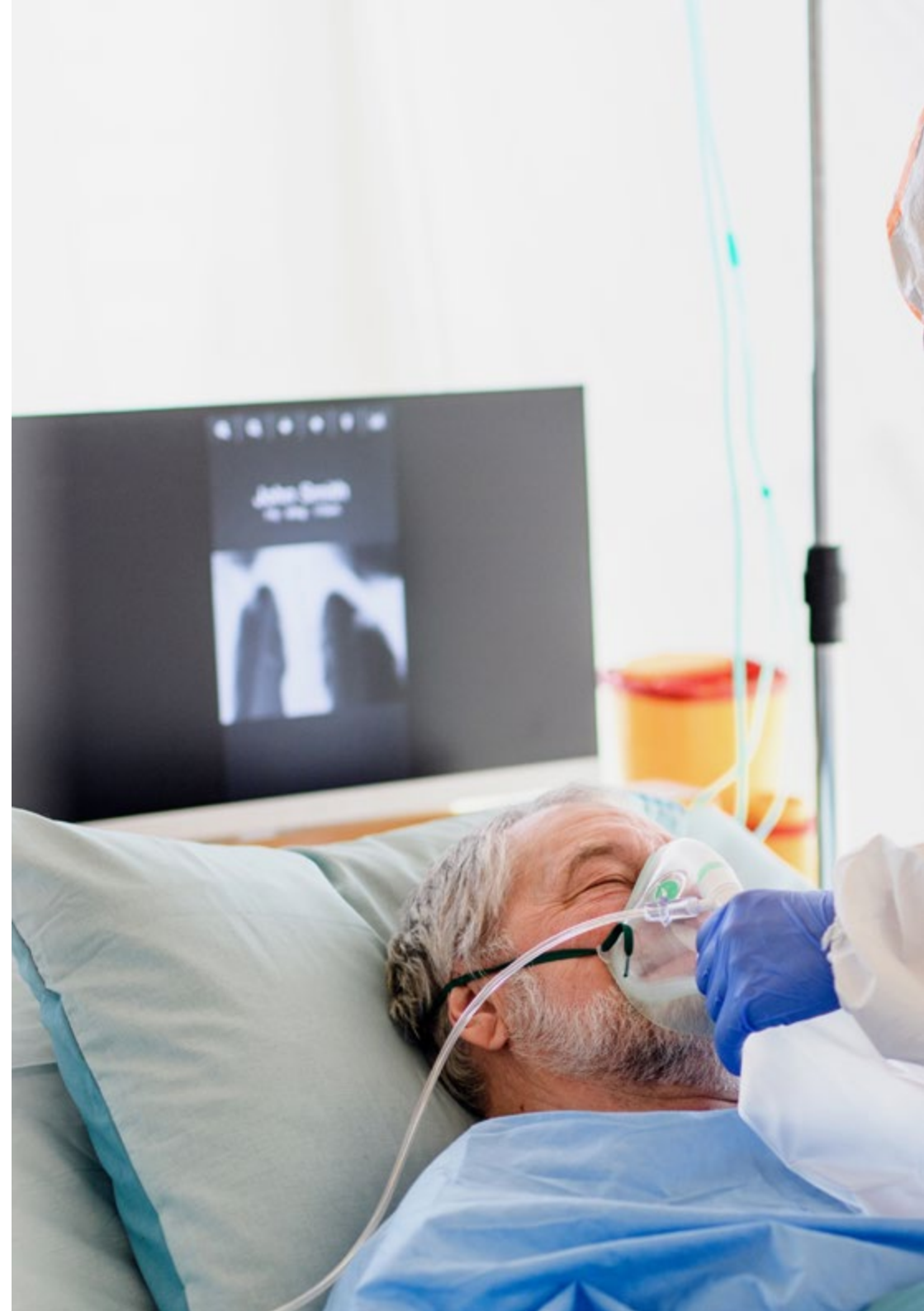

# Methodology

## At TECH Nursing School we use the Case Method

The effectiveness of the method is justified by four fundamental achievements:
