In 2016, of the total 56.4 million deaths worldwide, 33% were due to infectious diseases, 30% to cardiovascular diseases and 10% to cancer. The fight against disease will have two simultaneous fronts: infectious diseases and chronic non-communicable diseases.

These factors, interacting with each other, have conditioned that we should not consider any part of the planet reasonably isolated from the rest, nor impossible the appearance, reappearance or dissemination of imported or apparently eradicated infectious diseases in our environment.

The complex international epidemiological situation so far this century, exemplified by the deliberate release of *Bacillus anthracis* spores as a weapon of bioterrorism to cause pulmonary anthrax in victims who inhaled them, the emergence of West Nile virus as a pathogen in the United States, the epidemic of Severe Acute Respiratory Syndrome (SARS), the zoonotic spread of monkeypox in the United States, the threat of pandemic influenza, the Ebola epidemic in Africa, the emergence of yellow fever cases in Angola, coupled with the re-emergence of dengue and cholera, the emergence of new arboviruses in the Americas region, The emergence of new arboviruses in the Americas, such as Chikungunya and more recently Zika, together with morbidity from other endemic infectious diseases, such as HIV/AIDS, leptospirosis, tuberculosis, community-acquired pneumonia and the increase in antibiotic resistance with the development of multidrug-resistant bacteria, all of which highlight the unprecedented need to improve the process of training and development of human capital in order to increase the competence and performance of all the personnel necessary to face the challenges involved in controlling and dealing with biological, hospital and public health emergencies that guarantee the quality and safety of health care for the population in any part of the world.

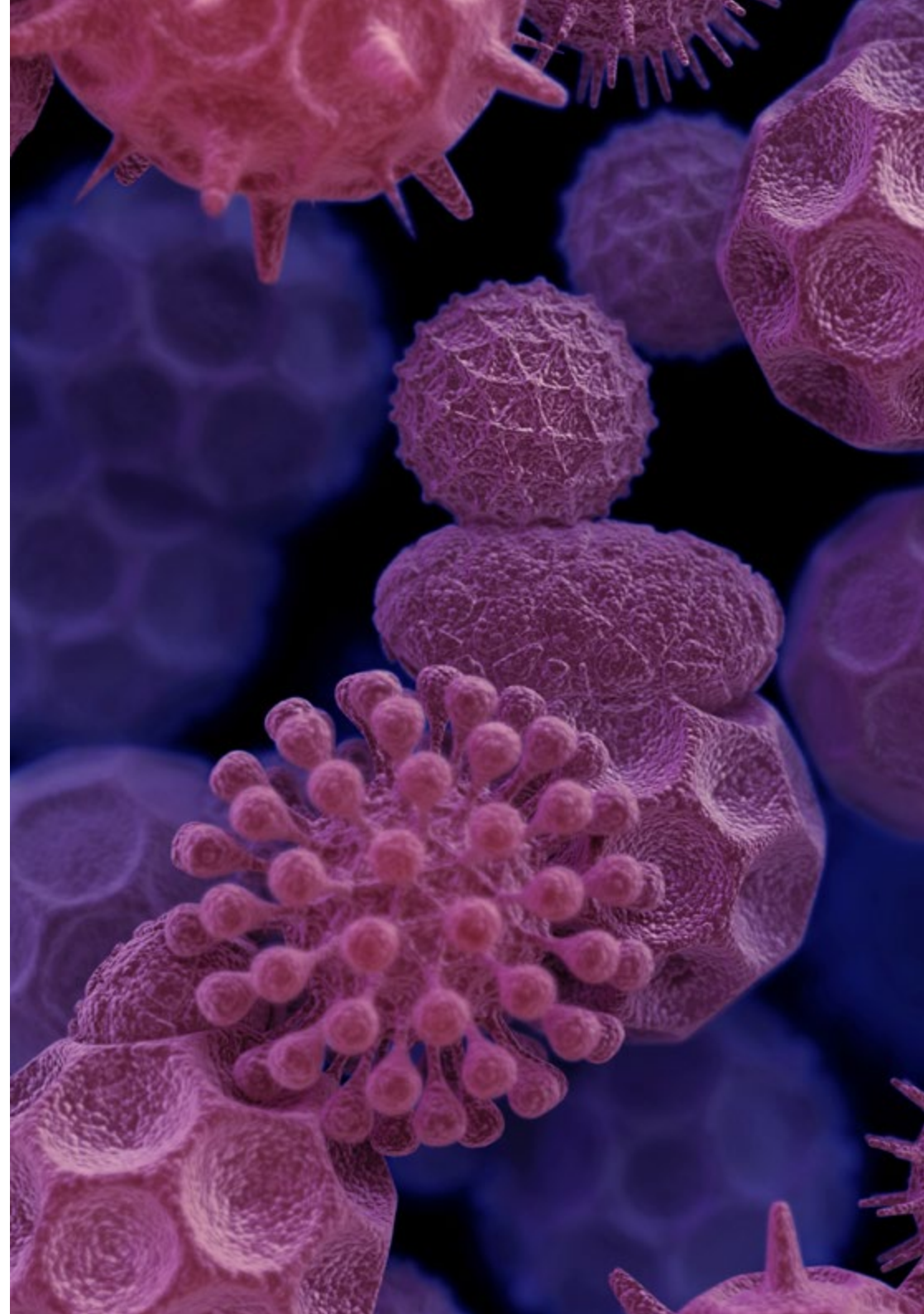
