# Introduction

In this sense, pharmacists need to be updated and promote continuous training in the knowledge and compliance with the standards for the correct preparation and quality control of Master formulae in order to achieve the required level of quality.

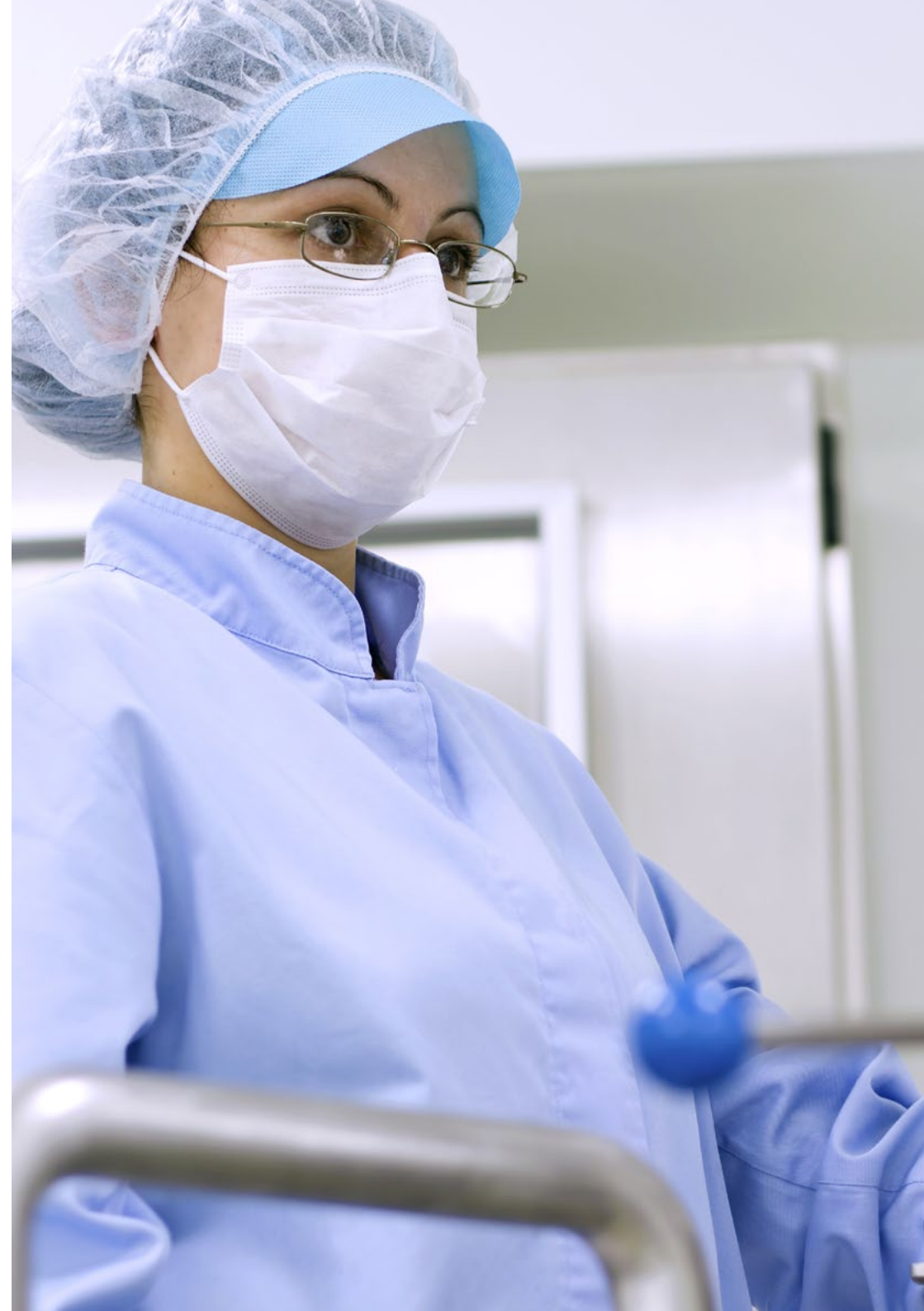

# Methodology

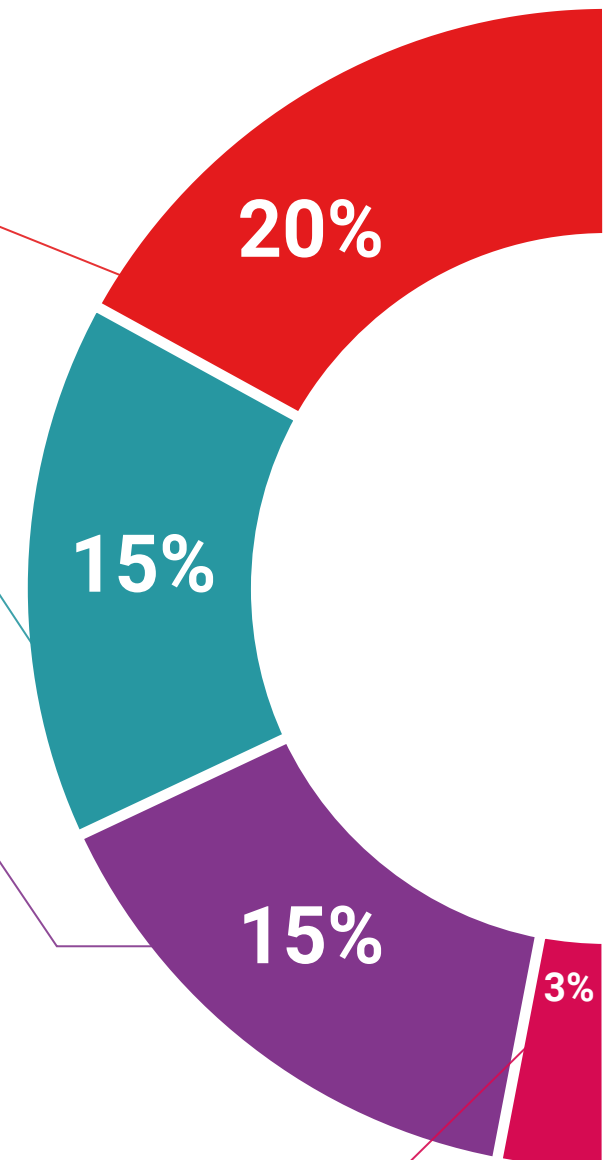
