## **Civil Liability Insurance**

# **General Conditions of the Internship Program**

The general terms and conditions of the internship program agreement shall be as follows:

- 1. - **4. CERTIFICATION:** Professionals who pass the Hybrid Professional Master's Degree will receive a certificate accrediting their stay at the center.
