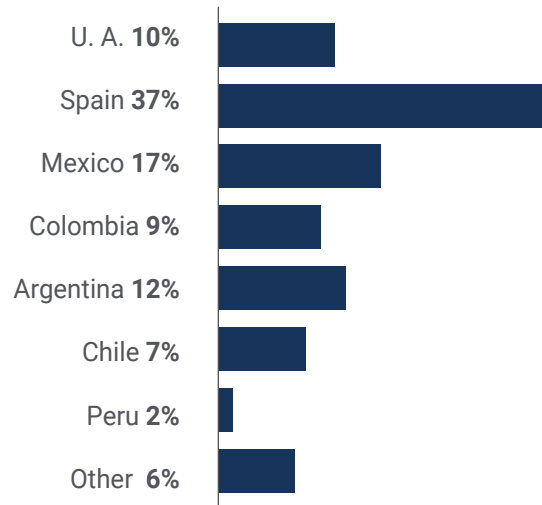


Educational Profile

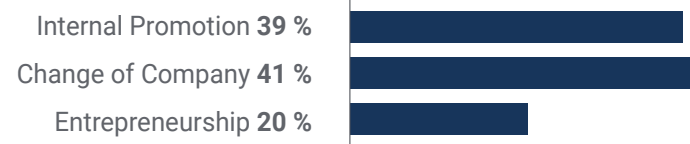
