# Introduction

There are also racial predispositions that are related to the age or sex of the animal. Dermatopathies can significantly reduce a patient's quality of life and even lead to death if the problem is not properly diagnosed and controlled.

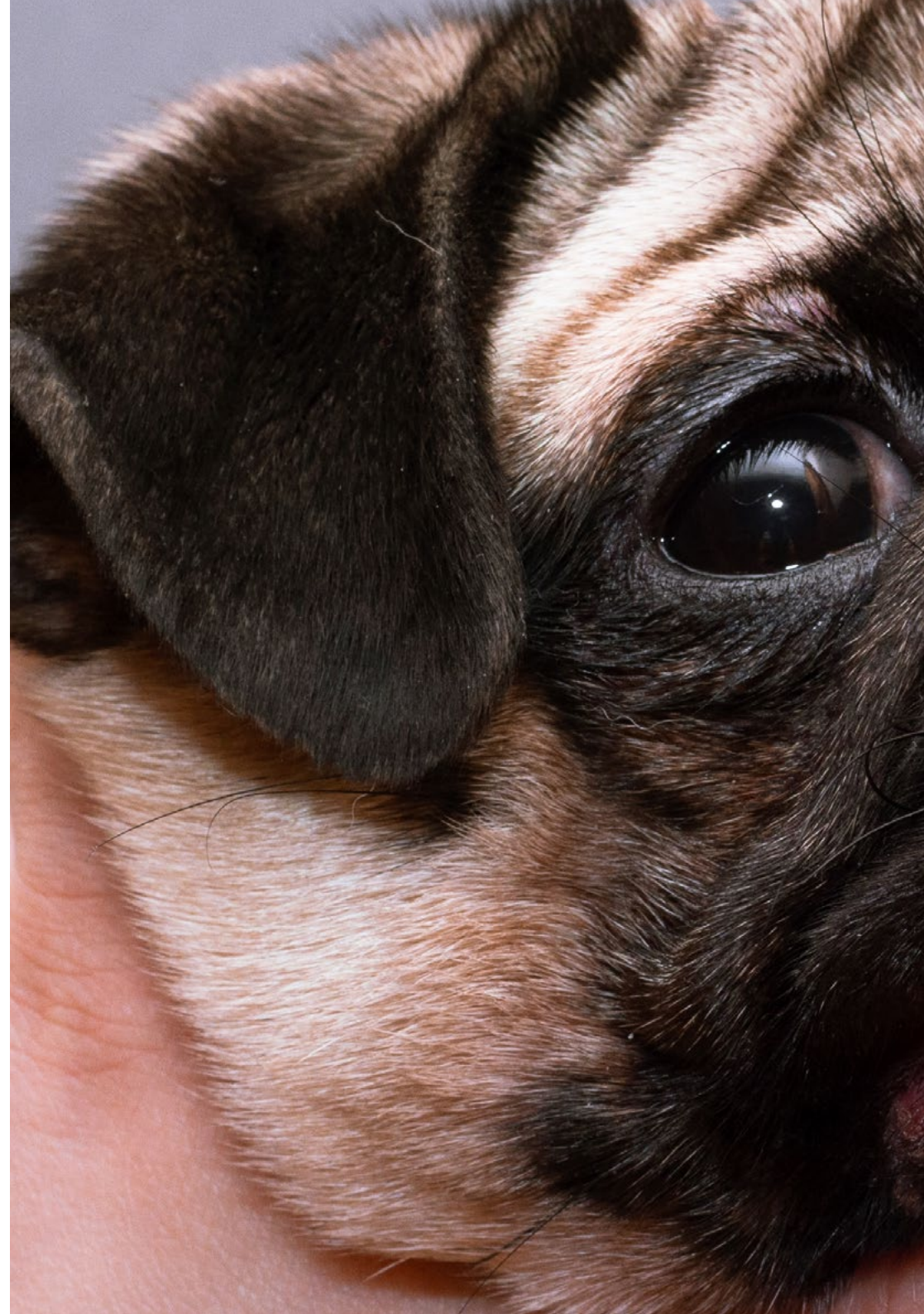

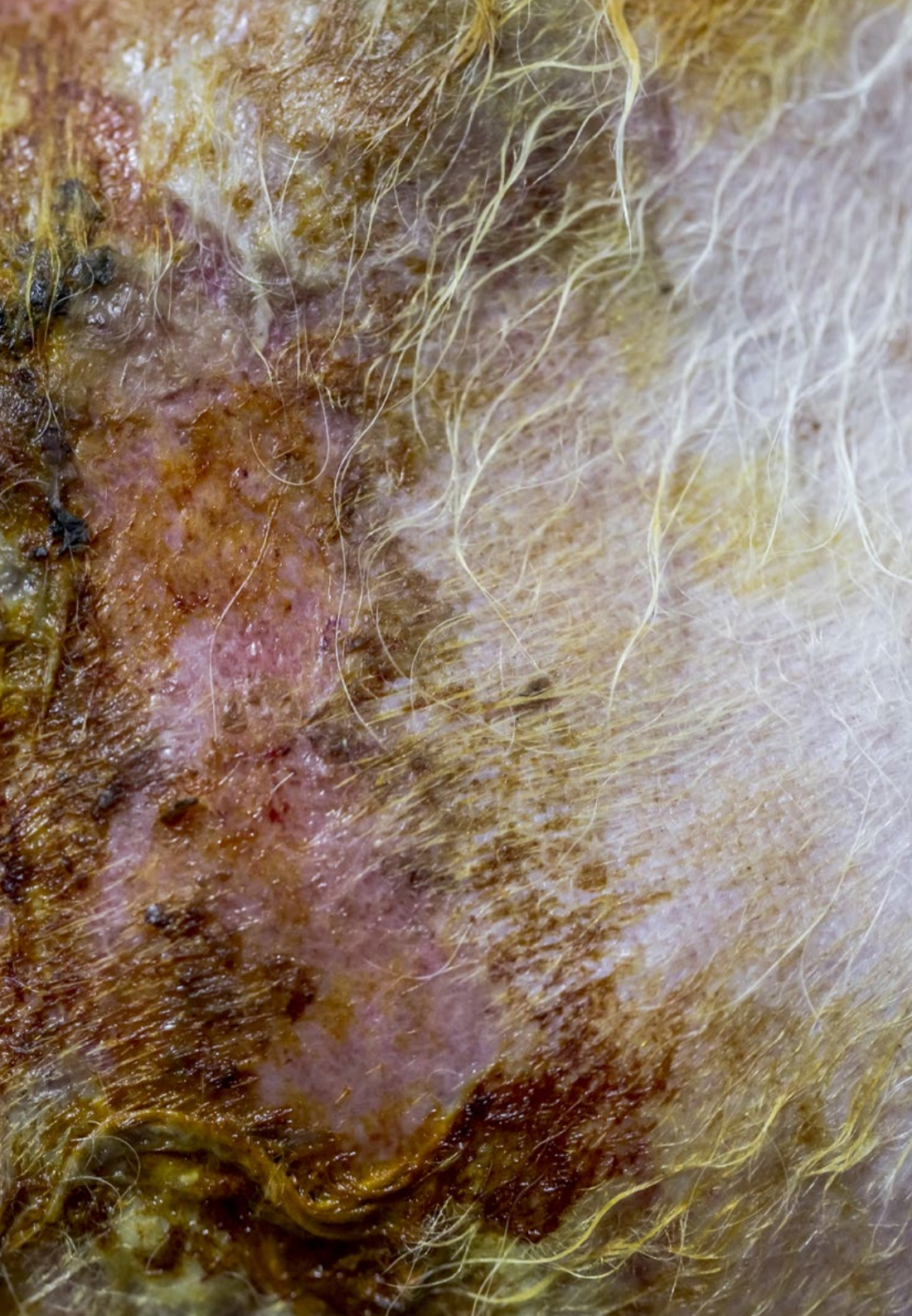

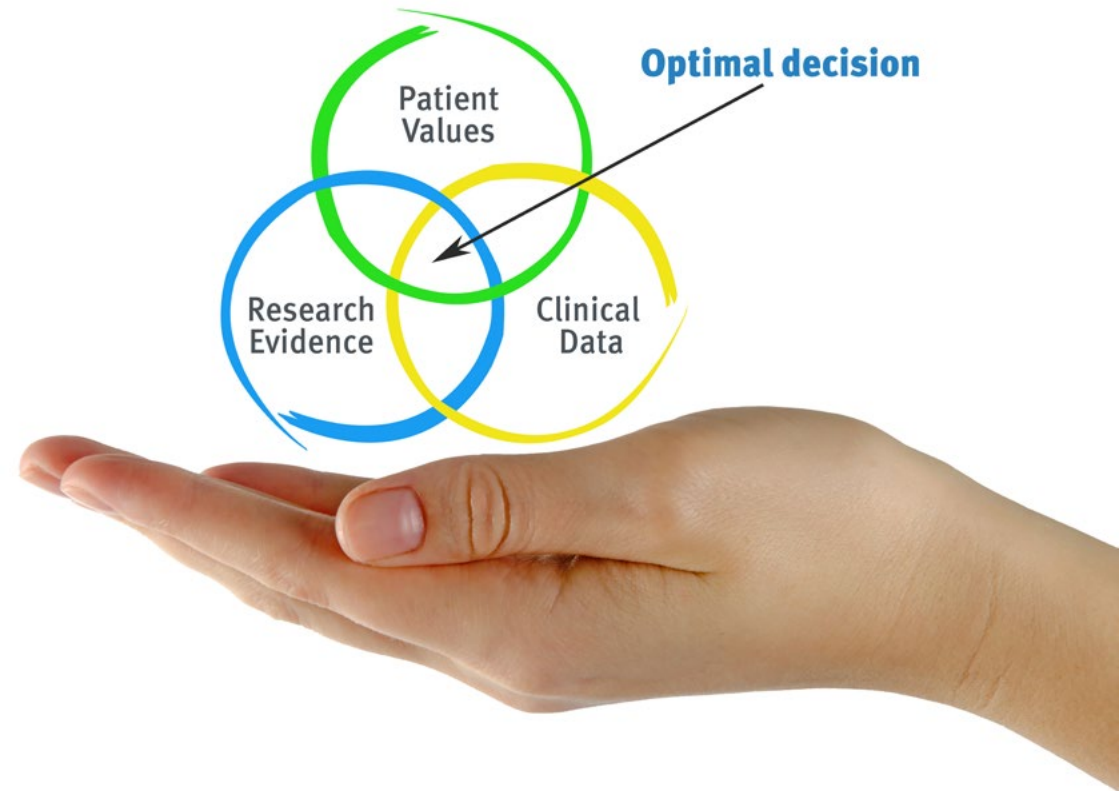

The effectiveness of the method is justified by four fundamental achievements:

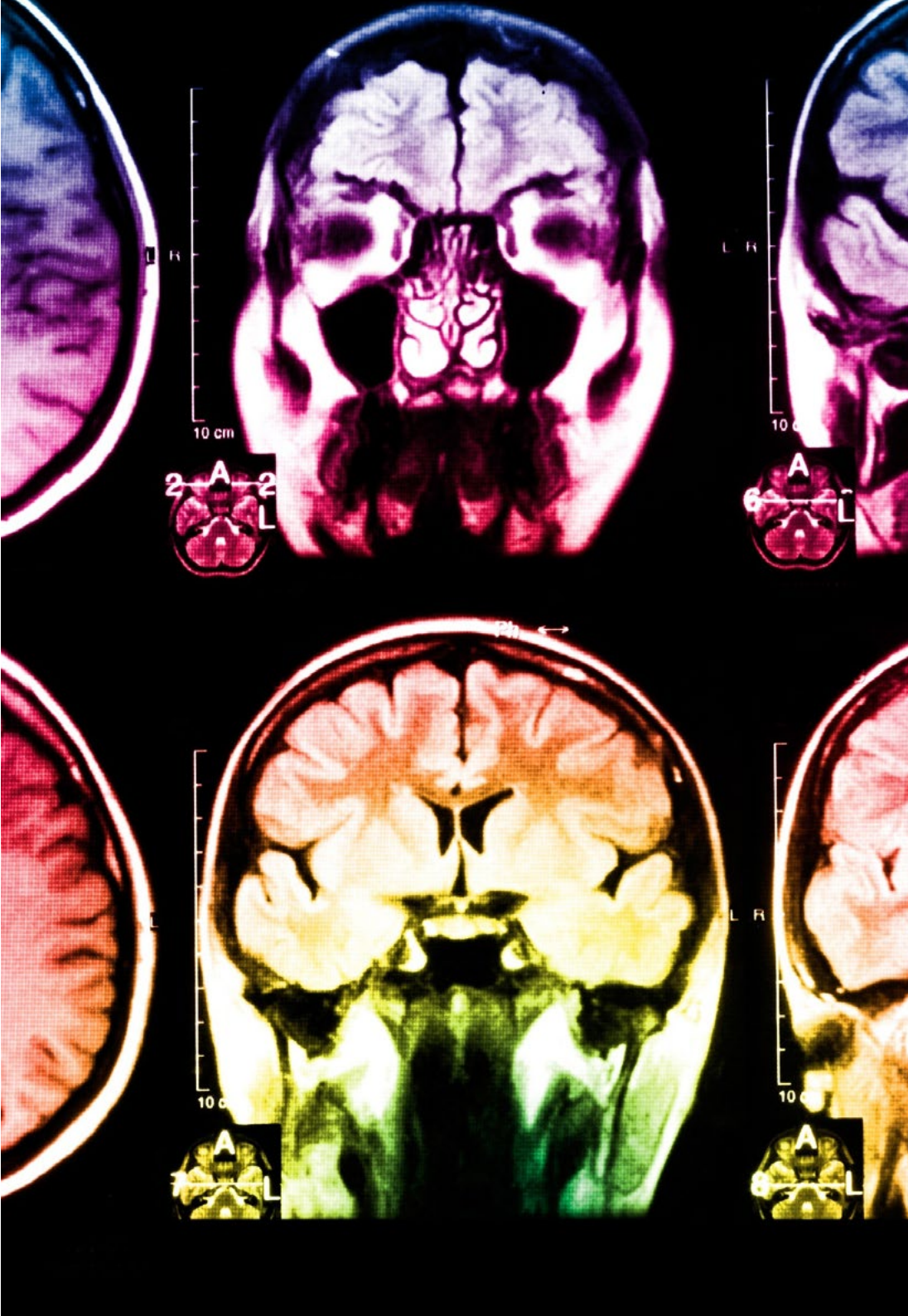

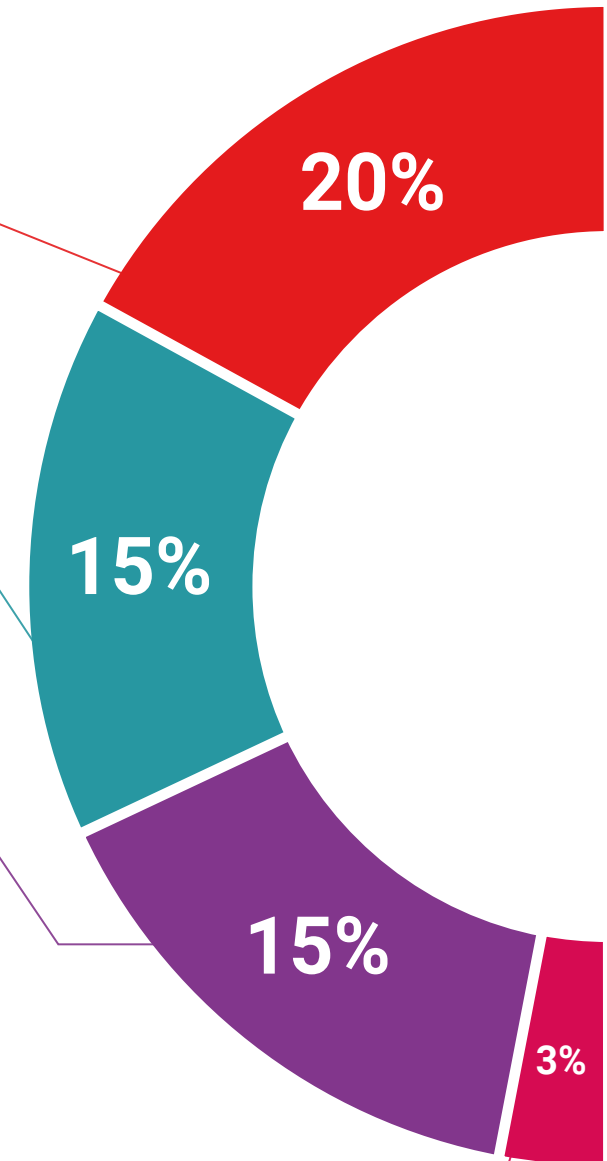

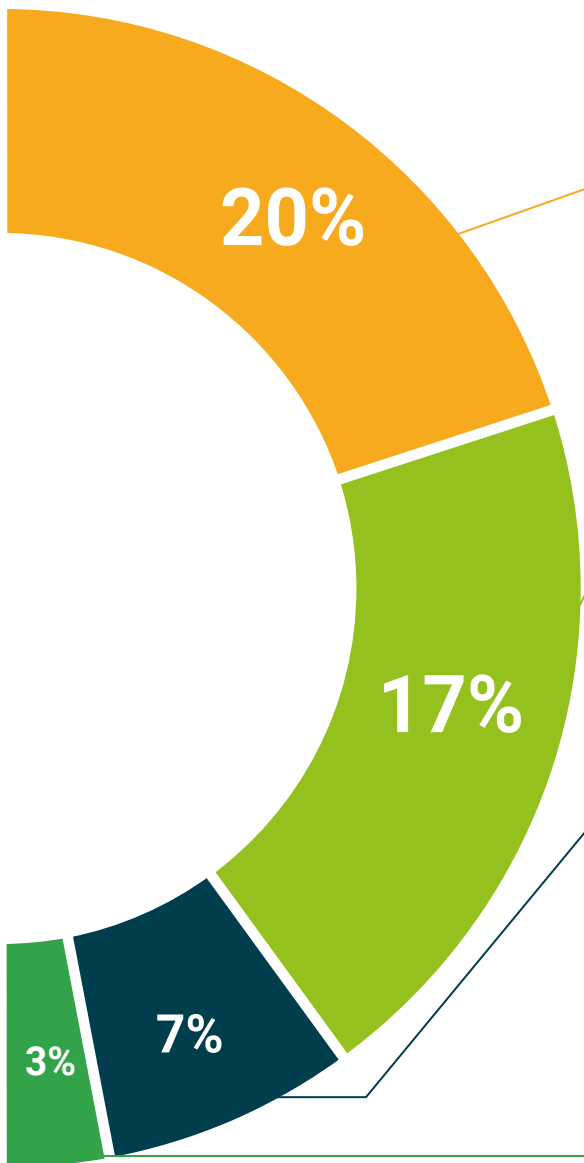
