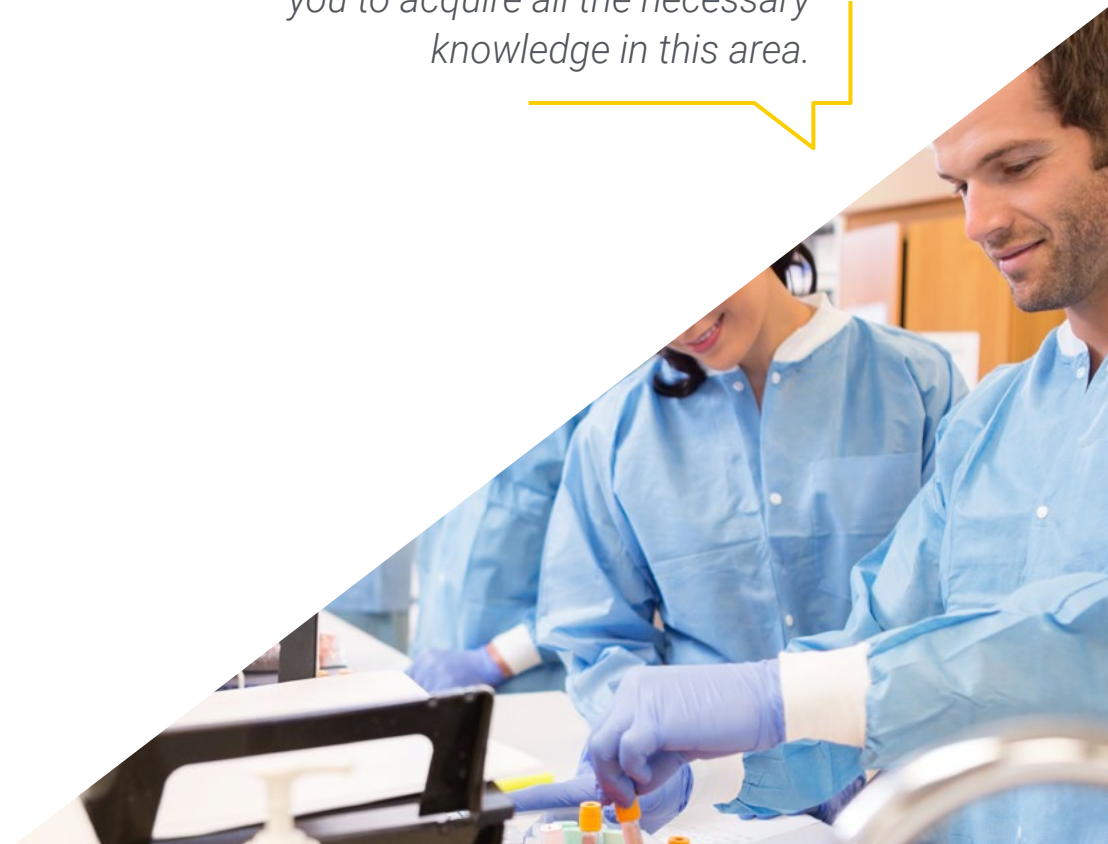

- ◆ Develop properly before an eminently oral trial in which the conviction of the opinion has to be reached after the oral intervention in the trial, subject to contradiction

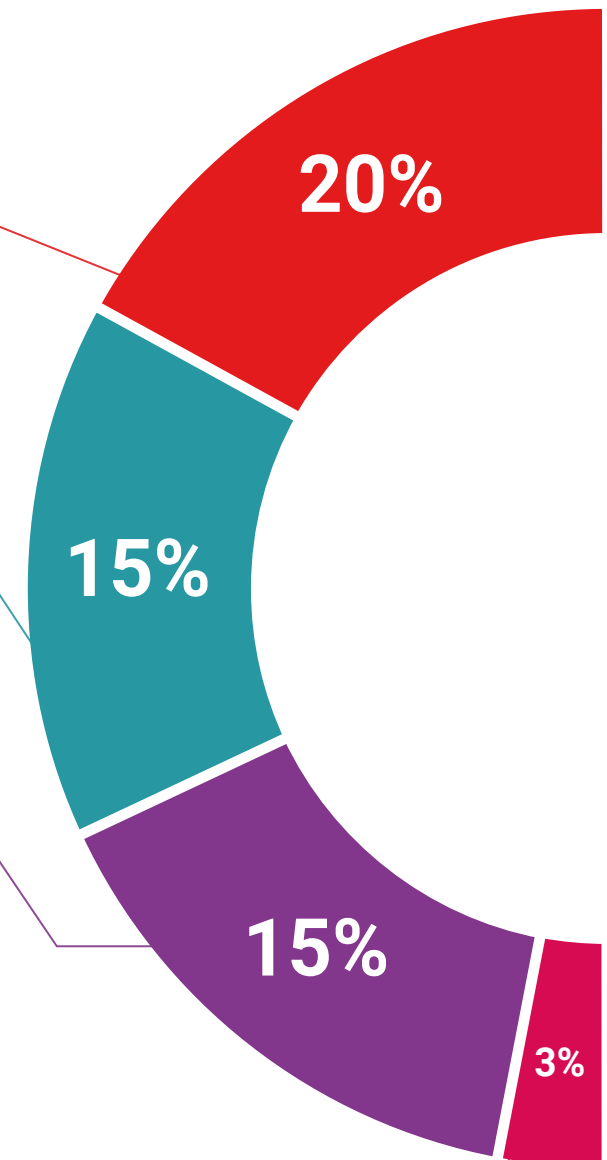
