# Introduction

Poultry farming by definition is the activity of raising and caring for poultry, in addition to its commercial exploitation. Poultry farming includes a variety of species, the best known of which are hens and chickens, which would be included in classic poultry farming, being the most important commercially, but it also includes geese, ducks, quails, partridges, pheasants and ostriches that are included in the so-called alternative poultry farming.

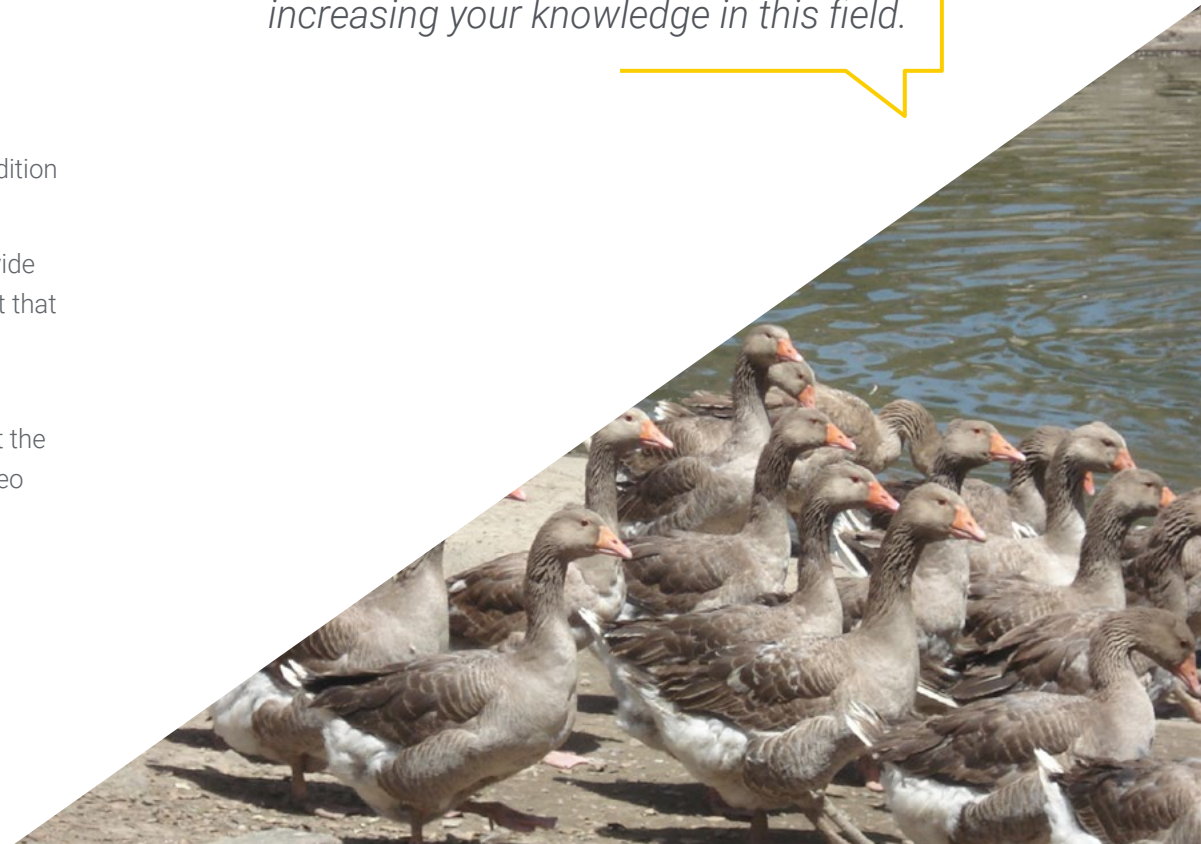

# 05 Methodology
